# 1 Title: Blended Teaching

#### 2 Title: Mentoring

**Objective:** Mentoring aims to provide structured guidance, support, and encouragement to students, enhancing their overall college experience and preparing them for future endeavors.

The Context: Mentoring has been one of APC's key aspect leading and guiding students in times of need. APC has always emphasized the bond of mentor and mentee and the role it plays in student's life. The context behind mentoring is multifaceted and driven by several factors such as knowledge transfer, personal and professional development, networking and relationship building, adapting to change and innovation.

The Practice: One mentor is assigned per group of 25 students in each semester. Monthly mentoring sessions are conducted by each mentor where various crucial topics like students' individual performance, attendance, overall conduct in college and other aspects are discussed. Same information is made available to their parents though the parent what's app group. In each semester, parent teacher meeting is convened by the mentor discussing mentees performance. In case of short fall in students' attendance, letters are sent to the parents as well as they are informed via call for the same.

## Problem encountered and resource required:

In the past academic years, despite having streamline mentoring program, some discrepancies were observed. Looking deeper in the issue, it was identified that mentor kept on changing each year, so it was difficult to create deeper connection with the students. The Issue was rectified and now attempts are made to keep the same mentor for the span of two year. This would help to create a good rapport between mentor and mentee.
